**Three Main Social and Health Related Projects as “Corporate Social Responsibilities”**

1. **Undertaking of Free Reconstructive Surgery sessions including various birth defects, burn deformities and following major accidents / developmental for the underprivileged / backward areas / tribal areas and offering a lease of Fresh Start in life through the Reconstructive Surgery. Doctors from Bombay, Amravati, Ludhiana, Gwalior, Akola and also U.S.A. joined his team. Many nurses, medical assistants and volunteers from different walks of life \ different professions started extending help to these activities.**

**Dr. Ashok Gupta during these 32 years, has been performing over 5000 Free Reconstructive Plastic Surgical procedures on underprivileged children at remote and tribal areas of different States like Maharashtra, Madhya Pradesh, Gujarat, Bihar, Punjab, Uttar Pradesh, Haryana and other parts of the Country.**

2. **Dr. Ashok Gupta also responded to the call on the nation and extended his highly specialized services to the victims of a number of natural and man-made calamities such as riots during the Lok Sabha Election 1984, Babri Masjid related violent episodes Dec 1992, the infamous Serial Mumbai Bomb Blasts 1993, heroes of Kargil War, victims of Bhuj Earth Quake, terrorist attack at Akshardham Temple at Gujarat, 2002, Serial Bomb Blasts in Mumbai 2003, Train Bomb Blasts in Mumbai 2006 and the recent Terrorists Attack / Siege of Mumbai on 26<sup>th</sup> Nov. 2008.**

3. **SAVE THE FACE “ACID BURN” Acid throwing Offence, impact on women, Prevention of Offences (By Acids) Bill 2008** physical and social disfigurement by throwing acid on women which causes grievous damage to their personal and professional lives. This project is undertaken to draw the attention of the competent authorities to give an overall concise view of the problems associated with acid throwing (Vitriolage) incidents, and the laxity of certain sections of the law, which allow the offenders to walk away with minimal punishment.

As a lead **PLASTIC AND RECONSTRUCTIVE SURGEON**, it is Dr. Ashok Gupta’s attempt to put forward access to the possible professional help and to stress upon the importance of suitable primary treatment as well as definitive reconstructive procedures to these patients. As an expression of responsibility to the community and to extend the benefit of scientific advancement in the field of **Reconstructive Plastic Surgery**, it is proposed to offer **Volunteer Services** to the needy at certain designated medical institutions. Highly experienced surgeon in the fields of **Reconstructive Plastic Surgery** across the country would be happy to extend these benefits to the Acid Burn Victims through the courtesy of Ministry of Health and Family Welfare or other such organizations (including NGO).

**Often these victims need multiple stages of painstaking reconstructive surgeries over and above a prolonged professional and personal rehabilitation program and needs continuous backing through the manpower / financial support.**
